Nomination Procedures

- Nominations may be submitted by any current or past member of the Cuesta College Foundation Board of Directors or College Trustee

The nomination consists of:

1. Name of nominee
2. Information describing **what** the nominee has done for Cuesta College
3. Examples of **how** the nominee has served the college and the community (specific examples as well as general observations)
4. How this service distinguishes itself beyond normal board service
