

# 2020 ANNUAL REPORT

### Measure L Citizens' Bond Oversight Committee



District wide Road & Parking Lot Improvements: COVID-19 put a halt to most in-person classes and resulted in many staff and faculty employees working remote. The Bond team used the opportunity to complete asphalt projects on both the SLO and North County Campuses. Phase 1 consisted of the SLO main entrances off Hwy 1, Parking Lot 5 & 6, 4000 complex engineering/technology yard, bookstore loading area and the service road. Phase 1 construction commenced in June and was completed prior to the fall semester in August. Due to the historically low cost of oil, another silver lining to COVID-19, the final project costs came in below the engineer's estimate and budget. As a result, the Bond team elected to roll out a Phase 2 asphalt project which consisted of converting the dirt parking Lot 1 to an asphalt lot, asphalt replacement in Parking Lot 2, 2A & 7, North County Parking Lot 11, the Facilities Services parking lot, and slurry seal of all perimeter roads. Phase 2 commenced September 2020 and is scheduled to be complete in early 2021.

(BOTTOM) The all dirt Parking Lot 1, servicing the track and fields, was converted into an asphalt lot with ADA parking.

### A Message from the CBOC Chair

The Measure L Citizens' Bond Oversight Committee is pleased to report significant progress on projects funded under the voter approved Measure L. The committee has the responsibility to verify to the best of its knowledge and belief that Measure L Bond revenues have been spent only for the purposes identified in Measure L.

The committee relies heavily upon the Independent Auditor's Report of financial statements, as well as a Performance Audit Report performed by certified public accountant firm, EideBailly. The 2020 Fiscal Year-End financial statements for Measure L were given a clean, "no audit findings," recommendation, and the performance audit testing indicated the San Luis Obispo County Community College District has properly accounted for expenditures held in the Measure L Bond Fund and that such expenditures were made for authorized Bond projects.

This annual report lists many projects completed and underway using Bond funding as provided by the First Issuance of Measure L Bond funds of \$75 Million in March 2015, the Second Issuance of \$73 Million in January 2018, and the Third Issuance of \$70 Million in February 2021. One final Bond Issuance will occur in 2024. The projects have been essential to both the San Luis Obispo and North County Campuses and the results are outstanding.

The future looks bright for the San Luis Obispo County Community College District with facilities improved to provide a quality education and life experience. The contribution of Cuesta College to the county is enormous and the Citizens' Bond Oversight Committee is proud to be part of this most beneficial program.

The San Luis Obispo County Community College District Measure L Citizens' Bond Oversight Committee wishes to report that, to the best of its knowledge and belief, the Cuesta Community College District is in full compliance with the responsibilities described in Article XIIIA, Section 19b0930 of the California State Constitution.

### SLOCCCD Measure L General Obligation Bond Under the Provisions of State Proposition 39

San Luis Obispo County residents voted November 4, 2014, to approve Measure L - Cuesta College affordable education, job training and campus repair Bond, a \$275 million general obligation bond. Funding from the bond is helping the college modernize technology, upgrade the failing infrastructure of decades-old classrooms and labs, and build new teaching and learning spaces.

After voter approval of Measure L, the College Board of Trustees established the Measure L Citizens' Bond Oversight Committee (CBOC) appointing ten members of the community serving staggered terms providing objective oversight of District bond fund expenditures.

The role of the Citizens' Bond Oversight Committee is to determine whether or not the use of the funds is consistent with the original bond measure, inform the public on District expenditures of bond proceeds and to publish an annual report of the year's Measure L activities for taxpayers of San Luis Obispo County Community College District.

The CBOC would like to thank our outgoing committee members for their service to the District and Measure L Bond; Duane Lieb (committee chair, at-large member), Susan Dresser (committee vice chair, support organization), Scott Lathrop (taxpayer organization), George Galvan (senior citizens' representative), Patrick O'Hara (business community representative), Gayla Chapman (at-large member), and Trinity Leland (student representative).

### Independent Auditors' Financial and Performance Audits

Fiscal Year Ending June 30, 2020

he Citizens' Bond Oversight Committee received the Independent Auditor's Report for the financial statements of the general obligation bonds of the San Luis Obispo County Community College District as well as a Performance Audit report on the uses of bond monies for the period of July 1, 2019 to June 30, 2020. The reports were prepared by certified public accountant firm EideBailly.

The Independent Auditor's Report states:

We have audited the accompanying financial statements of the San Luis Obispo County Community College District's (the District), General Obligation Bond Fund (Measure L), as of and for the year ended June 30, 2020... Our responsibility is to express an opinion on these financial statements based on our audit... In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the General Obligation Bond Fund (Measure L) of the District at June 30, 2020, and the results of its operations for the year then ended in conformity with accounting principles generally accepted in the United States of America.

The Performance Audit states that the objectives of our performance audit are to:

- 1. Determine whether expenditures charged to the General Obligation Bond Fund (Measure L) have been made in accordance with the Bond project list approved by the voters through the approval of Measure L.
- 2. Determine whether salary transactions charged to the General Obligation Bond Fund (Measure L) were in support of Measure L and not for the District's general administration or operations.

Conclusion: The results of our tests indicated that, in all significant respects, San Luis Obispo County Community College District has properly accounted for the expenditures held in the General Obligation Bond Fund (Measure L) and that such expenditures were made for authorized Bond projects.

### **About SLOCCCD**

San Luis Obispo County Community College District is a small-sized rural single college district that offers instruction and student support services as Cuesta College at three locations: the San Luis Obispo Campus, the North County Center, and the South County Site. In addition to serving as locations to offer instructional programs and student services, Cuesta College hosts various public events, recreational activities, and community education programs.

### **Technology Planning & Implementation Update**

During the 2020 year, the Information Technology department continued to utilize the Technology Implementation Plan and has successfully brought 90% of the San Luis Obispo Campus up to date with new CAT6A cabling, Alcatel-Lucent switches, Aruba Wireless Access Points and single mode fiber. In addition, IT has taken the District's phone system digital. This migration to VoIP (Voice over Internet Protocol) has provided each end user with new phone hardware while improving the reliability and quality of all communications. Moreover, this department specified and installed all technology for the newly opened Early Childhood Education Center on the Paso Robles campus.

### 2<sup>nd</sup> Issuance Project Updates

### R&B Shultz Early Childhood Education Center

Construction is nearly complete on the new one-story, 11,000 sq. ft. Early Childhood Education Center with 12,000 sq. ft. play yard and two exterior storage buildings. The new building will provide two levels of childcare (toddler and preschool) and include faculty offices, additional parking adjacent to the new building, and a dedicated teaching space for Applied Behavioral Sciences Childhood Education program. The furniture was delivered and installed throughout the building in mid-December. The new Children's Center is scheduled to move operations from the old modular buildings to the new building in March 2021. Although COVID-19 has impacted operations, most notably capacity limitations and separation of "shared spaces", the Children's Center is looking forward to expanding capacity with the additional preschool class by Summer 2021.

### **2000 Complex Renovations**

All buildings within the 2000 complex, except for building 2500, underwent HVAC, reroofing, and ADA upgrades as part of the 2nd issuance. ADA upgrades were completed in 2019 along with re-roofing for Buildings 2100, 2300, and 2400. In December 2019, construction for the HVAC upgrades commenced for buildings 2100, 2200, 2300, and 2400 along with the re-roofing of building 2200. All work on the 2000 complex renovations was completed in June 2020. The renovation for building 2500 is planned for the 3rd issuance under the Districtwide Roofing and HVAC Modernization project.

### SLO Campus Center Design

Early in 2020, the Bond Team, along with Administration, evaluated options to renovate existing or build new for a San Luis Obispo Campus Center. The goal was to enhance and simplify the experience for the first-time student or visitor of Cuesta College. The outcome of the evaluation and planning effort resulted in moving forward with the original plan, a new SLO Campus Center building. The team kicked off the conceptual design process in June 2020 and by December the new SLO Campus Center concept was finalized. The new (approx.) 32,000 square foot, two-story building will reside where the existing Administration Building sits now. The project will also include re-design of the Education Drive entrance and loop along with modifications to both parking lots 3 and 4 to tie the design all together. Design will continue into the third issuance with construction anticipated for spring 2023.

### North County Sitework Improvements

The Sitework Improvements project consists of a new main entrance loop off Buena Vista Drive and a central campus pedestrian promenade. The project will be constructed in two phases, the first phase of construction commenced in August 2020 and is anticipated to be complete in early 2021. Phase 1 features a pick-up/drop off area, flagpole plaza and bus stop. Phase 2, central campus improvements will be completed in 2021 and will tie the existing and future buildings of the campus together. Anchored on either end by the Campus Center and Learning Resource Center, the project includes interlocking pathways and gathering spaces, landscaping and trees, electronics charging stations and hydration stations.

The North County Sitework Improvement project's new main entry off Buena Vista Drive welcomes visitors with the beautiful Campus Center, one of the first capital projects completed under the Measure L Bond in 2018.





### **Modernization/Renovation Project Updates**

### **ADA Upgrades**

Early in 2020, design commenced for the ADA upgrades in the 4000s, 5000s, and 6000s complexes. The scope of work includes complete remodels of all the restrooms and drinking fountains. The drawings received DSA approval towards the end of the year and construction is anticipated to commence in late spring 2021. The ADA Upgrades Districtwide project will be funded by the 2<sup>nd</sup> Bond issuance.

### **Building Electrical Switchgear Replacement**

During winter 2019, electrical switchgear was replaced for the 1000s and 2000s complexes. The electrical switchgear is nearing end of life for the remaining complexes. As part of the 3<sup>rd</sup> issuance, the electrical switchgear will be design and replaced in/around buildings 3100, 4100, 5200, and 6100. The work is anticipated to take place during winter breaks, starting in 2022, to minimize the impact as complexes will be without power during construction.

### **Roofing & HVAC Upgrades**

Re-roofing and HVAC replacement projects for the 4100, 4300, 4400, 6200 and 7100 annex buildings were publicly bid in July and September respectively. The re-roofing project started in August and by the end of 2020, the project was substantially complete with only minor punch list items remaining. Due to the long lead time for equipment, the replacement of the HVAC is scheduled to start in January 2021.






### **District-wide Project Updates**
