Journal Article

Provide a Digital Object Identifier (DOI) for journal articles when it is available. Find DOIs from print publications or ones that go to dead links with CrossRef.org's free DOI lookup at http://www.crossref.org/guestquery/.

Journal Article, More Than Seven Authors

If the article you are citing includes 8 or more authors, include the first six authors, insert an ellipsis (...), and then include the last author listed.

Because online materials can potentially change URLs, APA recommends providing a Digital Object Identifier (DOI), when it is available, as opposed to the URL.

Including database information in citations is not necessary because databases change over time.

In-Text Citations

The last name of the author and the year of publication are inserted in the text at the appropriate point.

from theory on bounded rationality (Simon, 1945)

If the name of the author or the date appear as part of the narrative, cite only missing information in parentheses.

Simon (1945) posited that

When a work has two authors, always cite both names every time the reference occurs in the text. In parenthetical material join the names with an ampersand (&). as has been shown (Leiter & Maslach, 1998)

To cite a specific part of a source (always necessary for quotations), include the page, chapter, etc. (with appropriate abbreviations) in the in-text citation. (Stigter & Das, 1981, p. 96)

De Waal (1996) overstated the case when he asserted that "we seem to be reaching ... from the hands of philosophers" (p. 218).

If page numbers are not included in electronic sources (such as Web-based journals), provide the paragraph number preceded by the abbreviation "para." or the heading and following paragraph. (Mönnich & Spiering, 2008, para. 9)
