California Assembly Bill 361, (Chapter 165, Statutes of 2021) signed by the Governor on September 15, 2021, extends the authorization for local public agencies to continue to use teleconference meetings and waive certain Brown Act provisions, as previously addressed in Governor Executive Orders N-25-20/N-29-20/N-35-20.
