During the Spring 2013 Allied Health Advisory meeting, facilities were pleased with the performance of the Nursing Assistants that they hired from Cuesta College. Those at the committee were from Compass health who only hired two of Cuesta trained students.</p> | <p>a. Benchmark met—No Change- Because CNA is a pre-req for LVN, the cap on the class for Fall 13 will be 30 for theory, with 2 clinical groups of 15. Compass has agreed to contract with us and provide a clinical instructor at Danish Care Center.</p> <p>b. The people in attendance at the Allied Health Advisory meeting did not have any suggestions for improvement. I learned that Nursing Assistant students in Skilled Nursing facilities are not required to have a background check- the Livescan is sufficient. | <p>DISCUSSION OF ASSESSMENT PROCEDURE & RESULTS & PLANS: Program SLO Presentation/Faculty Dialogue took place on 10/09/13 during the Allied Health Meeting. 3 faculty/1 associate director, and 1 Division Chair attended the 15 minute presentation. CNA employers state: Students have a good knowledge base and good customer service. Due to budgetary constraints, Acute Care Nursing Assistant class and ECG class have been discontinued. C.N.A. is the only class being offered in the Nursing Assistant Program.</p> <p>RECOMMENDATIONS FOR CHANGE: Dialogue took place on program needs based on SLO results. It was discovered that:. (1) the content of the newly developed facility survey did prove to assess the program SLO's correctly. (2) the method that was identified to improve the return of facility surveys was to discuss it in our by-annual Allied Health Advisory Meetings and distribute the survey to the members in attendance from the facilities in our community.(3) Determine if the Acute Care Hospitals are able to fill their need for Acute Care Nursing Assistants, since our program has been discontinued. We will improve efficiency by increasing the cap on the class from 15 students two times each semester, to 30 students once each semester. We will repeat the evaluation and discussion of Program SLOs yearly. No other comments.</p> | | | | |
