

Overview:

• This process is designed to address Cuesta College student concerns/complaints. First level concerns or complaints begin with a face-to-face meeting with the Instructor or College Employee prior to completing the formal concern/complaint report. A significant portion of these types of concerns/complaints are often resolved in this first level meeting. Please follow the Academic/Non-Academic Concern/Complaint resolution steps outlined below. Any questions regarding this process should be directed to the Student Support Resolution Coordinator at <u>donna_howard1@cuesta.edu</u> or 805-546-3192.

Instructions:

- <u>Academic:</u> Before completing the official concern/complaint form, the student should begin by first talking to the Instructor (if the issue is a concern regarding a grade being given in error or due to a miscalculation, the student must meet with the Instructor (1) after the final grade has been issued). If this first level meeting does not result in a resolution, the student should meet with the Division Chair of the appropriate discipline (2) to attempt resolution about any academic matters such as grades or course work. If there is no resolution, the student may then proceed with the <u>concern/complaint report</u>. This will take the concern to the next levels of resolution as outlined in the chart below.
- <u>Non-Academic</u>: The student should begin by first talking to the Employee (1) and then the Program Supervisor/Dean of the department (2) where the concern occurred. If there is no resolution, the student may then proceed with the <u>concern/complaint report</u>. This will take the concern to the next levels of resolution as outlined in the chart below.
