You must have the Connect access code for this class. You can buy the access code directly from McGraw Hill Publishers. There is an electronic book available within Connect, but I've been told it's less expensive to buy the bundle at the Cuesta bookstore. If you buy the book used, it probably will not come with the access code.

General information:

The course will begin on June 19th. We will use Connect for homework and the final comprehensive problem. All due dates for those assignments will be listed on Connect. Tests will be done in class. You are responsible to know all due dates. You are also responsible to have a backup plan in case your computer fails. There is access to computers on the Cuesta campuses.

Weekly discussions will take place on Canvas online. You will be graded on the discussions.

You must log into both systems regularly as there will be assignments due in both systems on a weekly basis. This is not a self-paced course.
