Early Priority to Register Conditions and Checklist:


- Eligible students who complete assessment, orientation and student education plan activities may receive early priority to register.
- Students with an Associate Degree or higher are exempt from these activities. Regardless, exempt students must complete these activities to receive early priority to register.
- All students must complete a comprehensive student education plan with a counselor by the time they complete 15 credits at Cuesta to maintain early priority to register.
- Upon completing 100 degree applicable credits or higher at Cuesta, students will no longer receive early priority.
- If placed on two terms of academic/progress probation, students will no longer receive early priority until returned to good academic standing.
- Dual Enrollment (Enrichment) students are not eligible for early priority.
