



# INTERNATIONAL STUDENT FINANCIAL CERTIFICATE

All international F-1 visa students must submit verification of having available **at least \$30,000.00** per academic year for as long as you are enrolled at Cuesta. The academic year includes the spring and fall terms. Summer enrollment is optional and would cost an additional **\$5,000.00**. Travel costs and cost for health coverage are not included. F-1 students are not eligible for financial aid nor for the AB540 exemption (exemption of nonresident fees for California high school graduates). **All fees are due and payable at the time of registration. If you do not meet your financial obligations, you will be out-of-status.**
